Wye Valley NHS Trust provides acute and community healthcare services to more than 223,500 people living in Herefordshire and Powys.

The Wye Valley NHS Trust Charitable Fund was set up to support and enhance the first class services provided by the Trust.

When making your donation to Wye Valley NHS Trust you can either specify which ward or department or on-going appeal you wish to benefit, alternatively your money can go to the general purpose fund.

How to make a donation

Donations can be made in the following ways:

Online: visit Justgiving or Virgin Money Giving websites where you can make a one-off or monthly donation.

Text: WVTH01 to 70700 with the amount you wish to donate.

Cash: complete the 'Donation form' opposite. Please do not send cash donations by post, instead a cash donation can be made in person at the General Office at the County Hospital main reception or at a community hospital reception.

Cheques and postal orders: complete the 'Donation form' opposite.

Credit/debit card: Please call the finance department on 01432 364176 stating you wish to make a donation over the telephone.

Gift Aid: Increasing the money you donate

Any donation given by a UK tax payer may be eligible for Gift Aid. This is a government scheme that enables us to reclaim 25p for every pound donated. If you wish to Gift Aid your donation, please ensure you sign the gift aid declaration opposite and provide your full name and address, including postcode.
