It is therefore not possible to provide indicative patient numbers for total use

Beriner[®] has been recorded for use by less than 6 patients during the time period requested. Section 40(ii) of the Freedom of Information Act 2000 requires that statistically low numbers that potentially identify personal data be withheld because of the Trust's obligations to protect personal data under the Data Protection Act 2018 and General Data Protection Regulation 2018.

No other medication listed below is in use in the Trust.

Unfortunately the clinical diagnosis information that would be required to answer this question is not recorded in one location and so it is not possible for the Trust to provide a response. The time necessary to compile information from around medicine services to try to answer this query would exceed that guided by the Information Commissioner's Office (ICO) so under section 12 of the Freedom of Information Act 2000 it is not possible to assist further.
