Please could I have a breakdown of Ovarian Hyperstimulation Syndrome cases reported to you annually since 2015. To be specific: 2015, 2016, 2017, 2018, 2019 and 2020 (up until present).

Please can I also have the statistics on how many cases were hospitalised each year in the same format: 2015, 2016, 2017, 2018, 2019 and 2020.

Please note that it is only possible to provide figures for those patients admitted with a diagnosis of Ovarian Hyperstimulation Syndrome, as Outpatients figures are not specifically recorded. Below is the Trust's current data from 1 January to 30/06/2020.
